The proposed school shall not use the premises including staff, play ground or any movable or immovable property of any other school registered under the respective Act of State Government.

The State Government will not bear any financial or administrative responsibility of the proposed school. The State Government will not be responsible, if the school/institution breaches of any rules/norms or regulations laid down by above said board.

The institution shall have to obtain necessary permission of Government of India and 6 other concerned authorities where it is necessary.

This NOC is valid for six months from the date of issue.

As soon as the School gets affiliation with CBSE, a copy of the letter of affiliation will sent to the Gujarat Sercondary & Higher Secondary Education Board, Gandhinagar as well as Education Department of the State Government and the school will get itself registered at Gujarat Secondary & Higher Secondary Education Board Gandhinagar
